- Code of Conduct



### From Our Health Center...Important Medical Information

To ensure a smooth, easy registration, be sure all of your camper's health forms arrive at camp 2 weeks before your camper's session begins. *Per Connecticut state law, no camper can attend MCC without a current health form which has been signed by a physician.* The physical must be current, or within the last 2 years. (maybe eliminate this, stated below)

At registration, our nurse provides a basic health screening, which includes a review of the Health Form, verification of allergy and diet constraints, collection of medications, and an assessment of illness, injury or communicable disease.

#### **Health Form**

This form must be filled out each year by the Parent/Guardian and the child's health care provider. A copy of a physical, performed within the last 2 years, and a current immunization form should be attached.

If your child takes either prescription or over-the-counter medicines, a parent/guardian AND physician must complete the "Authorization and Administration of Medications" section on the last page of the Health Form.

#### **Medications**

All medicines, including prescriptions, over-the-counter, and medicated creams are kept at the Health Center. The only exceptions are rescue inhalers for asthma and Epi-pens for severe allergic reactions.

- **Prescription Medicine:** It must be in its original container and labeled with your child's name and correct physician's order. If your child uses a rescue inhaler, please provide the Health Office with an extra. If your child needs to carry medicine at all times, please include the physician's order.
- Over-the-Counter Medicine: Our Health Center stocks some OTC medicines. See page 3 of the Health From. You must provide a signed consent for MCC to dispense OTC medicine. If your child needs an OTC we do not stock, please bring it to the Health Center in its original container labeled with your child's name and the physician's order.
- **Medicine Pickup at Camp's End:** Pick up all leftover medicine before you leave camp. Medicine left at camp after one week, will be destroyed.

#### **Camper Health and Injury Treatment**

Under the guidance of our camp physician, we evaluate health and/or injury conditions. Most often these conditions are treated at the Health Center. Sometimes they are treated at the Middlesex Clinic in Marlborough, or at Middlesex Hospital in Middletown. (does this statement lead parents to think the camp is responsible for taking to clinic for routine matters, like ear infections, strep-cultures for sore throats, or camp staff will transport for sutures or evaluation of sprained ankles etc.?) If your child is seen at the Health Center (this means every time a child walks through the health center door, a parent must be notified) or by a physician, we will notify you as soon as possible. You may take your child to his/her own physician for non-emergency conditions.

If your child is seen at the Health Center and it is determined that further medical care is needed, we will notify you as soon as possible. You may take your child to his/her own physician for non-emergency conditions.

#### **Hygiene is Important**

Take a few minutes to reinforce the importance of good hygiene—especially frequent hand washing, good diet, staying hydrated, applying sunscreen and bug repellant, and checking frequently for ticks.

Also, a reminder to change out of wet or dirty clothes quickly and dressing appropriately for the weather will ensure a comfortable camp experience. Our camp counselors and nurse will also reinforce the importance of hygiene.
